Our 27 hole tree lined course offers players the option of three different 18 hole layouts; Red, Blue and Gold.

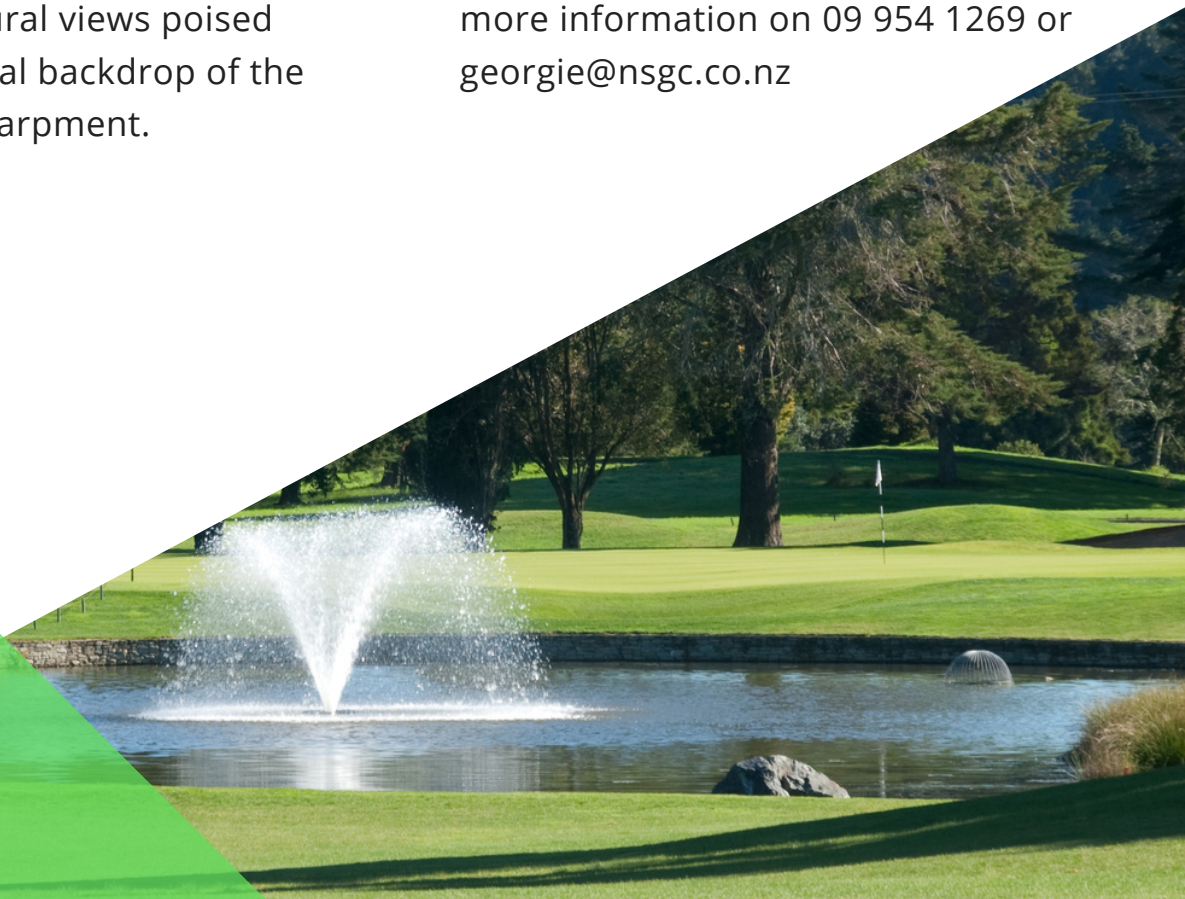
Each of these options covers undulating terrain and demands good course management from players of all levels.

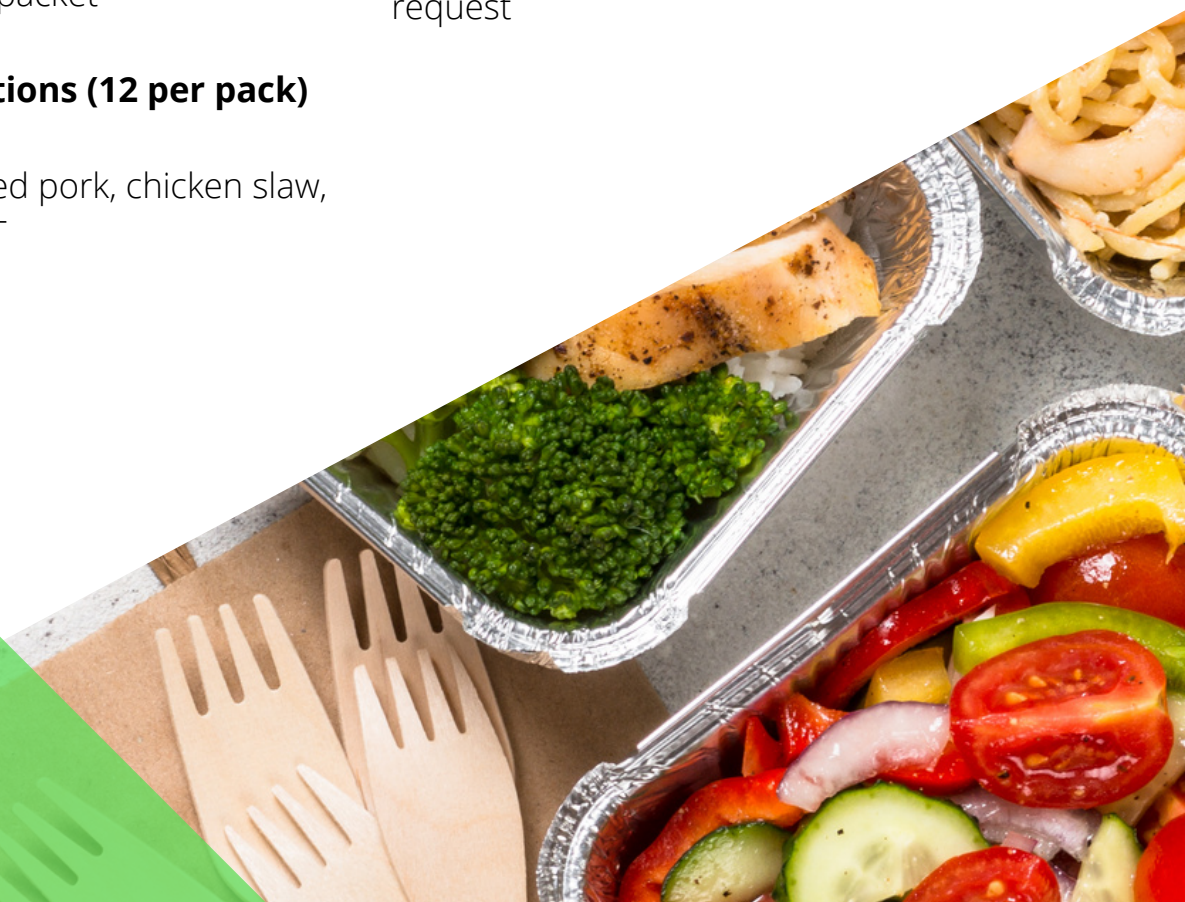

# TERMS AND CONDITIONS

## **Tentative Bookings**

A tentative booking will be held for 14 days for enquiries made outside 30 days prior to the event. For enquiries inside 30 days, your booking will be held for 3 days. If the client has not made contact within these timeframes North Shore Golf Club reserves the right to cancel the booking.

## **Confirmation of Bookings**

A deposit of 25% of the total quoted price plus a signed copy of the booking form is required to guarantee your booking. A receipt and confirmation will be provided after this has cleared.

## **Final Confirmation and Arrangements**

The client is required to finalise all arrangements no less than ten (10) working days prior to the event. Any changes to the number of players or golf carts will not be accepted unless otherwise agreed.

## **Guaranteed Numbers**

The guaranteed number of guests attending the golf event is required ten (10) working days prior to the event. North Shore Golf Club reserves the right to charge for meals in accordance with confirmed numbers or a final head count, whichever is the greater.

## **Golf Carts**

The client is required to confirm the number of golf carts required no less than ten (10) working days prior to your event. This is the number the client will be invoiced for.

## **Prices**

Prices will be maintained (within a 12-month period) once the Deposit and Confirmation of Booking is received, otherwise prices are subject to change. All prices are plus GST.

## **Payment**

North Shore Golf Club accepts payment by Cash or Credit Card (Visa & Master Card - 2% surcharge). Payment for the total function is required ten (10) working days prior to the function.

## **Cancellations / Wet Weather**

In the event the client wishes to cancel the event, the following cancellation charges will apply:

- Cancellation within 60-90 days of event – Full deposit
- Cancellation within 30 – 59 days – Full deposit plus 50% of projected costs
- Cancellation with 29 days of event – Full deposit plus 75% of projected costs

North Shore Golf Club understands that the client may need to change the date of the function. Every effort will be made to fit in with any changes where an appropriate space is available. The client's deposit will be rolled over to the new date.

North Shore Golf Club guarantees that should the course become unplayable due to heavy rain or is dangerous due to lightening, the client will have the option to re-schedule the event (where available) or receive a full refund of their deposit. However, as golf can be played in inclement conditions, this guarantee won't apply if the weather is merely unpleasant. Course decision is purely at the discretion of the club.

## **Dress Code**

North Shore Golf Club requires a high standard of dress at all times. Smart casual golf attire must be worn on the course and soft spiked golf shoes mandatory. Not permitted on the course are jeans, denim, football jerseys, tracksuits or beachwear. Mobile phones on the course are not encouraged but if necessary, players should first seek approval from other players in the group, or isolate themselves from the group.

## **Food and Beverage**

All food and beverage both on and off the course must be purchased from North Shore Golf Club. There is a strict no BYO policy.

Catering numbers must be confirmed ten (10) working days prior to the event and will be charged at the higher of either the confirmed number or the number attending on the day.

North Shore Golf Club are a fully licensed premise, with a full range of Food and Beverage facilities available and as required through Liquor Licensing Legislation, that no alcoholic beverages are to be brought onto the premises for consumption at any time.

## **Consumption of Alcohol on Course**

Alcohol can be consumed on the course from 10am (license requirement). All alcohol is to be supplied by North Shore Golf Club. Any alcohol that is purchased must be consumed before the end of the function. Two drinks carts are available and can either be cash or tab set up.

## **Covid Policy**

North Shore Golf Club will be following the guidelines for hospitality operations and as such, will be a CVC (Covid Vaccination Certificate) venue.

# TERMS AND CONDITIONS

## **Conduct**

The client is responsible for the general conduct of guests whilst on the premises of North Shore Golf Club and will comply with the Club's Host Responsibility Policy. The North Shore Golf Club Manager on Duty reserves the right to eject any person from the premises, should their conduct be deemed unreasonable or not in accordance with the Club's policies or procedures.

## **Function Rooms**

The Function Area will be provided to the client (subject to availability) free of charge for all bookings of 80 guests or more. Otherwise, the Function Room incurs a room hire fee of \$500 to account for room set up and staffing.

## **Damage**

The client is financially responsible for the cost of any damage sustained to the course, equipment or clubhouse by a person involved with the event, outside of the perimeters of normal usage wear and tear, with the exclusion of North Shore Golf Club staff.

Damage caused to property including linen, carpets or fixtures and fittings, resulting in the replacement of the property will be the financial responsibility of the client. North Shore Golf Club reserves the right to enforce a bond for any other function if we deem necessary.

## **Security and Insurance**

North Shore Golf Club will take all necessary care of the client's property but will take no responsibility for damage or loss of property or merchandise left at North Shore Golf Club prior to, during or after the event.

## **Smoking**

Smoking and vaping is prohibited in any area of the building or surroundings. Marked outside areas are available for the client's use.

## **Decorations**

The use of Confetti/Scatter is not permitted. Any other choice will need to be provided by the client. The client is welcome to decorate the room in addition to this provided nothing is nailed, screwed or glued to any surface of the venue. Please ask the Corporate Sales & Events Manager for advice of event staging and decorating. Setting up and removing all additional room decorations is the client's responsibility.

## **Crowd Control**

North Shore Golf Club reserves the right to insist on a Crowd Controller should we deem it necessary. This will be charged to the client, unless prior arrangements are made with the client's own Licensed Crowd Controller.

## **Public Holidays**

A 20% surcharge applies to the total Food and Beverage value of the function booked on a Public Holiday.

## **Noise**

North Shore Golf Club reserves the right to monitor and control the noise level of all sources of entertainment being held within the function space and its surrounds. North Shore Golf Club also asks that all patrons leave the function in an orderly and quiet manner, respecting residents that live close by.

## **Service of Alcohol**

North Shore Golf Club upholds the principals of 'Responsible Service of Alcohol' in accordance with the liquor license applicable to this premises. North Shore Golf Club reserves the right at any time during an event to refuse to serve alcohol to any person deemed to be intoxicated, and to exclude from the event any person, considered in the North Shore Golf Club's sole opinion to be acting unsuitably or inappropriately, and if necessary, to remove the person from the premises, without liability or recourse.

The client is asked to please advise their guests to bring their ID to avoid disappointment. North Shore Golf Club has the right to remove the offending guest/s from the premises or cease the service of alcohol entirely.

Gifts of Alcohol presented to guests that are not purchased on site must remain sealed whilst on the premises. Please advise your guests.

## **Function Commencement & Vacating of Rooms**

The client agrees to begin the function and vacate the designated room at the scheduled times agreed upon. In the event that a function should go beyond the agreed finishing time, North Shore Golf Club reserve the right to charge any additional costs incurred. Should the room be sold to another function, North Shore Golf Club reserve the right to vacate the client's function from the room.

## **Deliveries & Signage**

Items being delivered on the client's behalf must be boxed and clearly labelled with the Event name clearly marked. Drop off times must be arranged with the Corporate Sales & Events Manager. Although the utmost care is taken, no responsibility is taken for lost or damaged goods. Any items left on site will be disposed of after 3 days unless prior arrangement has been made.

## **Force Majeure**

When matters beyond the reasonable control of North Shore Golf Club impair or prevent North Shore Golf Club from being able to perform its obligation under the event contract, the client releases North Shore Golf Club from any liability for loss incidental or consequential to such matter.
