Corporate Membership and Benefits

Playing Rights / Membership Term

- o Strictly two named and two guest passes
- o Additional guests can play at Member Guest rate.
- o 12-month membership with auto renewal unless advised in writing to cancel prior to roll over date.
See your individual invoice for details.
- o Named card holders will be required to undergo an interview with our Golf Operations team prior to any membership application being accepted.

Named Card Holders

- o Full playing rights – See Club Programme book.
- o Retain club handicap at North Shore Golf Club.
- o Online Tee Booking.
- o Full use of driving range and practice facilities.
- o Can enter Club Competitions.
- o Can represent North Shore Golf Club in Pennants.
- o No Voting rights.
- o Rebates in the form of House Account credits for alcohol purchases. These can be spent in our Proshop, Sprig Bar and Bar. House Account credits are non-refundable.
- o Access to reciprocal clubs or courses.
- o Affiliate rates at other NZ golf clubs where applicable.
- o Club Professionals available for lessons and tuition (fees apply).
- o Access to club facilities.

Guest Passes

- o Can play accompanied or unaccompanied.
- o Play 7 days per week, excludes specific club events, set corporate events and competitions.

Tuesday – summer 12:30-3:00pm, winter after 12:30,

for bookings after 3:00pm please contact Golf Operations

Wednesday – morning field 7:18 – 9:00am and after 3:30pm

- o Driving range and practice facilities for warm up before round only.
- o No voting rights.
- o Capped at 100 rounds per card per year.
- o Private setting, can only be booked via individual login.
- o Group booking can only utilise one set of guest passes, bookings through Golf Operations.

Financial Terms

- o Annual fee for corporate membership subject to change annually.
- o Joining Fee \$1,500.00 for one new member or \$2,500.00 for both new members.
- o Payment or direct debit set up due prior to booking rights being activated.
- o Direct debit option incurs admin fee currently set at \$120.00 for 12-month period.
- o Direct Debit dishonour fee currently set at \$10.00 per default.
- o Outstanding or overdue balances will result in booking rights being removed and current bookings in system being deleted.
- o Course fee (paid for each round) \$6.00 for 18 holes, \$3.00 for 9 holes.
- o Prices valid as at 1st November 2024 and subject to change, without notice.
- o Cart, clubs or trundler hire separate, please book and pay through Proshop.
- o Driving Range Balls to be purchased through Proshop.

Member obligations and conduct

Designated users

- o Named card holders only are permitted to use their personal account and cannot be shared with other individuals.
- o Guest passes are for the sole use of the corporate to reward staff, entertain suppliers, customers or other business connections / networking.
- o Guest pass use is strictly not to be sold to other individuals for cash or services.
- o Violations may result in disciplinary action and/or termination of contract with no refund.

Behaviour and Etiquette:

- o Named card holders are required to read our welcome pack and sign the codes of conduct contained in this document.
- o Named card holders are responsible for their guest(s) also complying with our codes of conduct. This includes, but not limited to, dress code.
- o Penalties for breaches of our terms and code of conduct may result in a warning, suspension of privileges or termination of membership.

Booking and cancellation policy

Tee Time Reservations

- o Tee time bookings can be made via your Dotgolf online account, Proshop or Golf Operations for Named card holders.
- o Guest passes can only book through their Dotgolf login or an email to Golf Operations by a registered email address connected to the corporate membership.
- o Bookings open at 7:00pm for the following week ie 7:00pm Wednesday bookings open for the following Wednesday.
- o Only up to 4 future bookings may be held at one time. This is subject to change dependant on course availability.
- o Cancellations of tee times are required as soon as possible when you know you or your guests will no longer be able to attend. Late cancellation or no-show penalties may apply.

Liability and Insurance

- o All vehicles parked in our car park are done so at their owner's risk. Any loss or damage is not the responsibility of North Shore Golf Club.
- o The corporate members and guests acknowledge that North Shore Golf Club are not responsible for any injury or damage occurring on our premises.
- o Users accept all risks when entering and while on our premises. We are a sports facility with natural/associated hazards.
- o The corporate members accept all responsibility for themselves and their guest(s) and any damage caused to our property will be charged to The Corporate. This includes, but not limited to, damage to carts, hire clubs etc.

Transferability

- o Where a named card holder leaves the company you have the option to request for a transfer of name.
- o The existing card holder can be offered a transfer to an individual membership with no joining fee charged, there will be a membership fee payable to be calculated at the time.
- o New named card holder will be required to pay a joining fee. This charge also covers the cost of the transfer.

Amendments

- o North Shore Golf Club reserves the right to amend the terms and conditions of the membership at anytime, without notice.
- o These Terms and Conditions supersede any previous Terms and Conditions, these are valid as at 1st June 2024.

Termination

- o North Shore Golf Club reserves the right to terminate the membership without refund if any designated user violates the club's codes of conduct and/or membership terms.
- o In the event that this membership type is cancelled, North Shore Golf Club will give the affected parties 30 days' written notice and any outstanding value of membership that has been received will be refunded.
- o Membership is for a fixed period as outlined in their individual invoice. No refunds are given if member wishes to cancel membership within this fixed period.
- o Direct debit instalments will continue until outstanding money has been recovered even if the membership has been cancelled.
- o In the event that North Shore Golf Club is unable to retrieve outstanding funds due this matter will be passed on to an external agency at the Corporate Member's cost.
- o Notice in writing to cancel membership renewal must be received prior to roll over date.
